Immigration New Zealand reserves the right to request additional information in the course of assessing an application and to retain information and documents on file. INZ remains the right to interview clients at their discretion.

If you provide false or misleading information your application may be declined.

You are required to provide attested documents with your application. You do not have to provide original documents, but if you choose to, please provide a copy along with the original. All documents not in English must be translated by a translation service.
